# **Introduction to Printmaking & Drawing**

## **Course Description**

This course provides a survey of several approaches to print media. Concepts and techniques will be achieved through hands-on work both during and outside of class time, demonstrations, videos, guest presenters, and examples of various types of print media. Class projects will focus on relief, color layering, intaglio, print collage, and bookmaking. Technical guidance/supervision will be offered by both instructor and research associate.

## **Objectives/Learning Outcomes**

- Cultivate the ability to imagine, create and resolve a work of art
- Gain proficiency in a range of printmaking techniques,
- Learn and fine-tune the use of printmaking and drawing materials.
- Learn clean-up and safety procedures.
- Become acquainted with historical and contemporary artists and practices of printmaking.
- Become adept at using etching presses and working in a communal studio.
- Gain the conceptual vocabulary for analyzing, discussing, and critiquing one's own work as well as the work of others.
- Gain and implement the use of printmaking vocabulary.

## **Course Requirements**

- Expect to spend approximately 15 additional hours outside of class each week to complete assignments by the due date.
- Maintain clear communication with Instructor and Research Associate through email, and office hours.
- Stay informed about class meetings, videos, and assignments via Canvas.
- Regular check-ins will occur during class.
