Mastery Grading Policy: Every week you will be assigned a couple of questions separate from the normal homework that can be submitted on any Friday at 11:59pm through Gradescope. These questions, unlike the homework, are meant to be more challenging and may require research on material outside of the class lecture notes. Each question will be graded out of ten points and can be resubmitted as many times as needed with the goal of attaining a perfect score. While any of these questions can be submitted each week the cap is set for only two question submissions per week. You will be responsible for attempting four distinct mastery grading questions throughout the course and for each additional attempt will be awarded an extra point towards the total. The original total prior to any extra points will be determined from the four highest scoring submissions.
